Notes On Giro

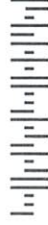
1. Your Giro application is only effective when the statement 'Amount to be deducted from.....' appears on the lower portion of your licence renewal.
2. Deduction will be only made from your financial institution/Bank account on the due date of the licence renewal.
3. Your financial institution/Bank statement will also show the deduction.
4. If you wish to terminate the Giro arrangement, please write to your financial institution/Bank to effect the termination and extend a copy of your letter to IDA.
5. If there is a decrease in the licence fee payable due to reduction in the number of licensed stations, written notice must reach IDA at least 7 working days before the licence renewal due date to stop Giro deduction.
6. If you wish to stop Giro deduction and wish to make payment by other means, your payment must be received by IDA 3 days before the due date of the licence renewal. Otherwise, the amount due on the licence renewal will still be sent to your Financial Institution/Bank for GIRO deduction. Payment may be made by e-payment through IDA's online Telecoms Licensing System at

7. You may arrange for another party to pay your licence renewal through the Giro deduction. You would need to state your Client ID on his/her Giro form.
8. Some financial institution/Bank levy a surcharge for unsuccessful deduction for reasons such as insufficient balance in financial institution/Bank account. Your financial institution/Bank will be able to assist you with enquiries of this nature.
9. For unsuccessful deduction, you would then need to pay the licence fees stipulated in the licence renewal by other means mentioned in Para 6 before the expiry date of the previous licence. Otherwise, a late payment fee shall be imposed for renewal of the licence after the expiry date of the previous licence.
